### Facility Restrictions

### RV Camping

All RV spaces are Sold and Assigned through the Will Rogers Memorial Center/City of Fort Worth office on-site. All locations available on a first-arrived, first-assigned basis.  
North Red Lot: \$60 per night. Adjacent to Pavilion.  
Yellow Lot: \$60 per night.  
Swine Barn Lot: \$30 per night. SW corner across from the Cowgirl Museum.

### RV Services

### Health Document Requirements

Per Texas Animal Health Commission  
Negative EIA/Coggins within 12 months.  
For horses coming in from outside the state of Texas, Negative EIA/Coggins within 12 months and Certificate of veterinary inspection within 30 days prior to entry.
