Stall Barn

All Stalls: \$90.00 for the weekend.
Reserve on-line or call USTPA Office to reserve stalls.
Stalls are assigned on a first-reserved, first-assigned basis.
Stalls are located in either the Richardson Bass building or the Multi-Purpose Building, Unit B.

Stall Bedding

Shavings are \$12.00 per Bag for the Large compressed bag (large and small flakes mixed each bag).
All Stalls will be Pre-bedded with two (unopened) bags per stall, and will be charged at the \$12 per bag rate for the two pre-bedded bags.
Additional shavings may be ordered on-site through Will Rogers Shavings Office
No Outside Bedding Allowed. Will Rogers Memorial Center will monitor outside shavings and will charge for all outside shavings at \$12 per bag.

Vehicle Parking

Vehicle Parking on-site, fee charged and collected by Will Rogers Memorial Center/City of Fort Worth.

Trailer Parking (non-RV)

Trailer (non-RV) Parking fee charged and collected by Will Rogers Memorial Center/City of Fort Worth.

Day-Haul-Ins

\$15.00 per day for Day Haul-Ins. This is a charge assessed and collected directly by the Will Rogers Memorial Center/City of Fort Worth.

Facility Restrictions

No smoking or tobacco allowed in buildings or arena.

Pet Restrictions

No pets allowed inside the Arena

RV Camping

All RV spaces are Sold and Assigned through the Will Rogers Memorial Center/City of Fort Worth office on-site. All locations available on a first-arrived, first-assigned basis.
North Red Lot: \$60 per night. Adjacent to Pavilion, closest to the John Justin Arena.

Swine Barn Lot: \$30 per night. SW corner across from the Cowgirl Museum; water and electric only, 30 amp; no longer than 33'.

RV Services

North Red Lot: Water, Sewer & Electric, 30Amp or 50Amp.
Swine Barn lot: Water and Electric only, 30 amp; no longer than 33'.

Health Document Requirements

Negative EIA/Coggins within 12 months.
For horses coming in from outside the state of Texas, Negative EIA/Coggins within 12 months and Certificate of veterinary inspection within 30 days prior to entry.
