**HANK HOLM SERIES RULES:** All classes are no ride limit with 1 Mandatory Draw. If you Pick 1, you must Draw 1. Each class is a 50% payback, excluding the Youth. A \$2.50 Sanction Fee will be added to each ride/entry. Additionally, a \$5.00 Office Fee will be charged per Rider per Day. A 1-4 Rating System is in place, contact Hank Holm for rating.

**HANK HOLM FINALS:** September 24th - 26th, 2021 at Double H Arena in Winslow, IL. **MINIMUM \$10,000 CASH ADDED TO HANK HOLM FINALS.** Rider must attend 3 shows shows to qualify for Finals. Rider must ride 4 times for a show to qualify. **CHAMPIONSHIP BUCKLES** awarded to Year-End High Money Earners in Each Division!

**USTPA RULES:** All classes, with the exception of the #10 Elite are 5 Ride Limit - 4 Picks/1 Mandatory Draw OR Draw All. All levels Pick 1/Draw 1. Each class is a 50% Payback with a \$5.00 Sanction Fee added to each ride/entry, excluding the #10 Elite. **USTPA #10 ELITE** is an 8 Ride Limit - Picks 1-3/Draw 1, Picks 4-6/Draw 2 OR Draw All. A \$12.00 Sanction Fee will be added to each ride/entry in the #10 Elite, with a 60% Payback. USTPA Rules and Ratings apply.

**USTPA ELITE 10 FINALS:** May 14th - May 16th, 2021 at the Will Rogers Memorial Center in Fort Worth, TX. **MINIMUM \$50,000 CASH ADDED TO ELITE 10 FINALS.** To be qualified for this years finals, riders must have attended last years World Finals in Amarillo, TX. Qualified riders have the ability to qualify more teams for Elite 10 Finals this Spring at our April Show. Qualified teams from the June, July, and August shows have the ability to ride at next years Elite 10 Finals.

**USTPA WORLD FINALS:** October 24th - October 31st, 2021 at the Tri-State Expo in Amarillo, TX. Attending 3 separate shows will qualify contestant for Finals. Rider must ride 6 times in either Team Penning or Ranch Sorting for a show to qualify. A combined total of at least 24 Penning rides and 16 Sorting rides from 3 Qualified shows (or More), qualifies the rider for all classes at World Finals.
